



OBAFOREX FUND MANAGEMENT POLICY

Fund management otherwise known as trading an account is where we trade the major currency of the world in the global market, we take advantage of the various rise and fall of currencies to make profit. As you are about to give us access to trade your account, it is important you know that trading CDF is highly risky but because we are professionals, we try to do our best because your profits also profits us. Now after a successful monthly trading, you place a withdrawal or if you seek our assistance to do so we can, but it is important you know that it is the broker that pays you and sometimes withdrawal could take up to 5 working days as it is an international transaction. On no account will you pressurize the company for your withdrawal as payment can only be made to your name.

It is of paramount importance that you know our company's policies which include


1. Minimum of \$10,000 and above.
2. The account will be traded by **OBAFOREX GLOBAL TRADING ALONE**.
NOTE: If we discover that a client attempts to trade on the same account we are managing, we will terminate the contract immediately, and there will be charges.
3. After managing the account at the end of each month, the PROFIT made at the end of the month will be shared 50/50, As well as LOSSES will also be shared 50/50 (but in a situation where your initial capital is lost as a result of trading the company gives back 50% of your capital back to your trading account, then it is your decision to make if you wish to place a withdraw or still let the company continue trading.
4. You are in charge of the account, which means you are in control of the withdrawal of fund from the account, so after making the withdrawal, you will then pay our share of the 50% to our company account.
5. Withdrawal can take up to or less than five (5) working days after placing a withdrawal on your account.
6. In a situation where there is an open trade at the end of the month on the account, we are trading, we would need some time to be able to close the trade. May be a week or there about.

7. You can top up your account, but that would be after sharing the profit made at the end of the current month of trading.
8. We manager Synthetic, Forex and Cryptocurrency Account.
9. You can only terminate your trading contract after three months and you will have to inform us one month ahead, also note that you will be charged 25% from your capital for bridging the contract if you decide to terminate this contract within the first three (3) months.
10. Clients with \$25,000 account have the privilege to withdraw even before the end of the month with the conditions that a 30% profit has been made and confirmation that there isn't any open trade in the account as at that moment, but always remember to notify us before any withdrawal.
11. Obaforex Global Trading is also a funding agent with all our partner brokers, it means that we have the right to fund a client's trading account, but that doesn't mean we are in control of your money or we have your money just because we funded your trading account, we only funded your trading account and then you giving us access to trade your account is also a different thing.
NOTE: So clearly what we are saying is, funding of account and trading of account are two different aspect of the company's services.

2. Get your account verified, but note that without verification of your trading account, withdrawal cannot be made.
